DECISION # 33 (051 – 166)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellants written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Saddat Hussain Shah and Syed Ali Hammad Kazmi, nominees of Live Stock Exporters Association of Pakistan, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. During the hearing the council for Respondent has requested that to submit the desired documents which show that his nominee is entitled to be legitimate member of the subject Association. Despite of lapse of considerable time no documents were submitted till the closing of office time on November 15th, 2023. As such the Respondent has failed to establish his entitlement to be nominee on Corporate Class, despite the request made by his Council.
2. Whereas the judgment cited by the said complaint is binding on the FPCCI, whereas the said judgment are not applicable on the instant case.

The nominations received from the subject Association seem to be in-valid. Accordingly the objection(s) are accepted and the names of subject nominees are hereby removed from the Provisional Voter list.”

Hearing Proceedings:

It is mainly contented by the Appellant that the said nominee of the association are not eligible to be nominated by the said Association as they have no relevancy of business as per TOR of the said Association. In addition to this objection has also been raised about the nominations on their respective classes.


The nominee on Associate class shows that his firms are not body corporate. He furnished his NTN profile showing that he is duly registered by Income Tax authority. But neither of the two businesses mentioned in his tax profile relates to live stock. Therefore, he has failed to establish relevance of business with the Association.


As far as the nominee on Corporate class is concerned, tax return has been submitted which shows that his company does not have turnover of more than Rs. 50 Million. Besides, as per FBR profile his business “Al-Saddat Associates” is engaged in construction whereas “T4T Solutoins” is engaged in IT services. As such he is not entitled to be nominee of the said Association on Corporate Class.


Decision of the Election Commission of FPCCI:

In the light of above, this appeal is disposed of in aforesaid terms and both the nominees of Live Stock Exporters Association of Pakistan are still excluded from the Provisional List of Voters.

This order is passed on Thursday, 23rd November 2023.
