DECISION #34 (052 - 169)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Farooq, nominee of Pakistan Electronics Manf Association, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

- The council for the subject nominee has produced membership certificate, along with the SECP Certificate, Goods
 Declaration, etc. which shows that he has completed two years membership of the subject Association.
- 2. Whereas the Tax return shows that the turnover of the nominee is more than 493 Million, etc.
- 3. Whereas the judgment sited by the said complaint is binding on the FPCCI, whereas the said judgment is not applicable on the instant case.

In view of the above, the nomination received of Mr. Hamid Waheed nominee on EC&GB Corporate Class from All Pakistan Solvent Extractors Association seem to be valid. Accordingly the objection(s) are declined."

Hearing Proceedings:

This appeal has been instituted by Mr. Muhammad Ali Farooq, Director M/s. Pakistan Airconditioning and Refrigeration Corporation (Pvt.) Ltd.

In order to provide both the parties an equal right of representation and plead their respective stances, the Election Commission of FPCCI granted both parties with the hearing opportunity on 20th November, 2023 at FPCCI Head Office Karachi.

Mr. Ghulam Sabir Malik, Advocate High Court, appeared for the Appellant while Mr. Asad Ulah Jan, Advocate High Court appeared on behalf of the Respondents. The main contention(s) of the Appellant are:

The nominee has been nominated as Chief Executive of HM Extraction Ghee and Oil Industries (Pvt.) Ltd. but his NTN profile does not show this company.

In response, the learned Counsel for the Respondent produced Form A of SECP showing Mr. Hamid Waheed as Director of HM Extraction Ghee & Oil Industries (Pvt.) Ltd. He also furnished copies of income tax returns, sales tax returns and other documents to support his stance.

Decision of the Election Commission of FPCCI:

The documents provided on behalf of the Respondent supports his eligibility for the respective class. On the other hand, no evidence has been furnished by the Appellant to substantiate his contentions. As such, the instant appeal is not maintainable and is hereby dismissed.

This order is passed on Thursday, 23rd November 2023.
