DECISION # 36 (054 – 171)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Ms. Shafqat Ali, nominee of Chamber of Small Traders & Small Industry Gilgit, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

After going through the said arguments and the documents referred/ submitted, my finding are as follows;

The learned Counsel for the Respondents has produced / submitted documents which shows that the turnover of the nominee is more than the threshold lever of Rs. 50 Million. Beside the said documents he has also produced two year membership certificate issued by the subject Chamber. As far as licence is cornered the said chamber has already applied for the renewal of their license.

In the light of above the nominee of the subject Chamber seems to be valid. The Compliant is declined. “

Hearing Proceedings:

It is mainly contended that said Chamber license is expired. Beside the said objection it has also been contended by the learned Counsel that both nominations by the said Small Chamber do not qualify the basic requirement of small chamber.

The learned Counsel of the Respondent submitted the NTN Profile along with Income Tax Returns of both the nominees and both are found eligible being a member of Small Chamber.

Decision of the Election Commission of FPCCI:

In the light of above, both the nominations are still valid in the provisional list. The instant appeal is disposed of according.
