PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Haji Muhammad Afzal, nominee of Sarhad CCI, against the decision of the Secretary General of FPCCI, passed on the objections filed by Dr. Muhammad Arshad, nominee of Pakistan Cotton Fashion Apparel Manufacturers & Exporters Association.


It is important to note, that Haji Muhammad Afzal, nominee of Sarhad CCI has missed the first forum of objection to the Secretary General of FPCCI in terms of Rule 18(4) of the TOR 2013, and the appellant is not considered for hearing at the level of the Election Commission of FPCCI.

Decision of the Election Commission of FPCCI:

The Appellant has missed the first forum of objection to the Secretary General of FPCCI in terms of Rule 18(4) of the Trade Organizations Rules 2013. Therefore, under Rule 18(6), the appeal is not maintainable. Hence dismissed.


This order is passed on Thursday, 23rd November 2023.


