## DECISION # 39 (057-A - 175)

### **PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)**

Consequent upon Appellant written representation / appeal to the Election Commission of FPCCI, received on 17<sup>th</sup> November 2023 in FPCCI Head Office Karachi from Dr. Shahzad Arshad, nominee of Pakistan Cotton Fashion Apparel Manufacturers & Exporters Association, against the decision of the Secretary General of FPCCI, passed on the objections filed by Haji Muhammad Afzal, nominee of Sarhad CCI.

It is important to note, that Dr. Shahzad Arshad, nominee of Pakistan Cotton Fashion Apparel Manufacturers & Exporters Association, has missed the first forum of objection to the Secretary General of FPCCI in terms of Rule 18(4) of the TOR 2013, and the appellant is not considered for hearing at the level of the Election Commission of FPCCI.


Furthermore, at the earlier stage the Counsel of Haji Muhammad Afzal, nominee of Sarhad CCI, has already withdrawn from his objections on the nominees of Pashin CCI, filed by Haji Muhammad Afzal, and the Secretary General has passed the following order:

“Before the hearing could commence, the Complainant withdraw his complaint. Therefore, this complaint is dismissed as withdrawn.”


**Decision of the Election Commission of FPCCI:**

The Appellant has missed the first forum of objection to the Secretary General of FPCCI in terms of Rule 18(4) of the Trade Organizations Rules 2013. Therefore, under Rule 18(6), the appeal is not maintainable. Hence dismissed.
