DECISION # 42 (065 – 188)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Shakir Ullah, nominee of Khyber CCI, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“The learned Counsel for the Respondent has produced evidence that the nominee of the subject Chamber on Corporate Class has a valid Sales Tax Registration. He has also produced evidence which shows that his turn over is well above the threshold level of turn over as required under the TO Laws.

The objection as instituted by the Complaint seem to be invalid. The complaint is declined.”

Hearing Proceedings:


The main objection of the learned Counsel for the Appellant is that the Chamber has a defunct license and that the nominee of the said chamber does not qualify to be member on their respective class.

The learned Counsel for nominee on corporate class show that the turnover of the said nominee is more than the required threshold level as required and also for Associate class nominee has produced documents showing that he is eligible.


Decision of the Election Commission of FPCCI:
