## DECISION # 44 (067 – 194)

### PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18<sup>th</sup> November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Farooq, of Pakistan Electronics Manf Association, against the decision of the Secretary General of FPCCI, as follows:

#### Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

The learned Council for the Respondent has submitted the two years membership certificate of the subject Association. Beside the said documents the council has also submitted number of other documents which shows that he is qualified to be member of the said association.

In view of the findings and the available records, the nominee Mr. Ahmed Iftikhar Chaudhry as GB (Associate) is fully competent to be nominated by the Pakistan Chemical Manufacturers Association. The Complaint filed by the objector is declined."

#### Hearing Proceedings:

The Appellant has contended that the nominee of the said Association is not eligible as he is not related to the TOR of the said Association and also no details has been provided which shows that the said nominee even has any relation with M/s. Shaheen Grinding Mills Pvt Ltd.

The learned Counsel for the Respondents has produced Form 29, showing the name of the nominee as one of the directors of M/s. Shaheen Grinding Mills Pvt. Limited. He has also produced the invoices and documents showing relevancy of trade of the Chemical Manufacturers Association.

**Decision of the Election Commission of FPCCI:**

In the light of above, the said nominee is a valid member of the said Association.

This appeal is devoid of any merit and same is declined.

This order is passed on Thursday, 23<sup>rd</sup> November 2023.
