PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon written representation / appeal to the Election Commission of FPCCI, received through e-Mail on 17th November 2023 in FPCCI Head Office Karachi from Appellant Ms. Saima Rizwan, President (Claimed) WCCI Hazara Division, who is not representing FPCCI on General Body and Executive Committee Member of FPCCI for the year 2024-25, against the following decision of the Secretary General of FPCCI, filed earlier by Ms. Saima Khanum, former President (Claimed) WCCI Hazara Division, who is also not representing FPCCI on GB & EC for 2024-2025:

Decision of the Secretary General:

“Since, the appellant is not the member nominated by any Trade Body on the Executive Committee and General Body of FPCCI for the year 2024-25, hence the objections raised by the Appellant cannot be entertained, as per Rule 18(4) of TOR 2013 and FPCCI Circular dated 4th November 2023.”

Decision of the Election Commission of FPCCI:

The Election Commission of FPCCI, hereby seconds the decision of the Secretary General of FPCCI. Furthermore, Ms. Saima Rizwan, President (Claimed) WCCI Hazara Division, is also not representing FPCCI on General Body and Executive Committee Member of FPCCI for the year 2024-25. Therefore, the appeal cannot be entertained.
