Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Ms. Mumtaz Akhtar, nominee of Islamabad Women CCI, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

- The learned Council for the Respondent has submitted the membership certificate for last two years in respect of the nominees. Also tax details has been submitted. As such the said two ladies are competent to be nominee of the subject Chamber.
- 2. The Council also submitted that the subject Chamber has already applied for the renewal of the said chamber.

Therefore, on the findings and available records, the nominations received from the WCCI Karachi South are found to be valid. Accordingly the objection(s) are declined."

Hearing Proceedings:

The Council for the Appellant has raised objection on the renewal of the said chamber. He also raised objection that no proof of entitlement has been produced or shown by the nominee which shows that she is eligible to be nominee on corporate class.

The learned Council for the Respondent has produce her FBR statement which shows that the turnover of her company is around Rs. 386 Million. As far as the issue of license is concerned she has produce the application of the renewal letter along with the copy of the pay order.

Decision of the Election Commission of FPCCI:

In the light of above this appeal is devoid of merit and is hereby declined and the nomination received from WCCI Karachi South are valid in the provisional list.
