## DECISION # 49 (076 – 213)

### PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellants written representation / appeal to the Election Commission of FPCCI, received on 18<sup>th</sup> November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Farooq, nominee of Pakistan Electronics Manf Association, against the decision of the Secretary General of FPCCI, as follows:

#### Decision of the Secretary General:

“The only objection raised by the learned Council for the Complaint is that the nominee on Corporate Class has no concerned with the business of the Association. In reply to the said Objection the learned Council for the Respondent has submitted valid documents showing him to be member of the subject Trade Body, his council also submitted Form 29 along with Import documents showing that nominee company has imported goods which are directly related to the business of the said Trade Body. He also submitted proof of business.

The name of the subject nominee is held to be validly been sent from the said Trade Body.”

#### Hearing Proceedings:

Through this Appeal the Appellant has raised the same objection on the Corporate nominee of the said Association, that the nominee NTN profile does not show the business entity which is member of said Association, no proof of required turnover of Corporate class member has been produced.

In this regard all the necessary documents showing entitlement of the said nominee to be nominated on Corporate class have been produced including Form 29 showing him as Director of the Company, Import Documents, turnover of over Rs. 50 Million etc.

**Decision of the Election Commission of FPCCI:**

In the light of above this appeal is devoid of any merit and the same is declined.

This order is passed on Thursday, 23<sup>rd</sup> November 2023.
