DECISION # 72 (108 – 277)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellants written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Raza and Mr. Muhammad Haider Raza Naqvi, nominees of Mandi Bahauddin CCI, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my findings are as follows;

The learned Council for the Respondents has submitted their two years membership certificate issued by their Chamber. As far as the issue of Corporate entitlement of the respective member is concerned, no proof of required turnover of Rs. 50 Million. Even the RTO of the said nominee is of Islamabad.

In the light of above both the nominees seems to be invalid. The Complaint is allowed.”

Hearing Proceedings:

During the hearing the learned Counsel of the Appellant submitted the documentary evidence of Rs. 50 M turnover of Corporate Class nominee. The NTN of Corporate nominee is showing RTO Islamabad, and business address as Phalia Road, Mandi Bahauddin.

With respect to Associate Class nominee, the firm is showing as M/s. Hamza Dairy Farm, in RTO Islamabad, and business address at Phalia Mandi Bahauddin.

Decision of the Election Commission of FPCCI:

In view of the documents provided by the Appellant, with respect to the nominees of Corporate and Associate Class, the nominations received from Mandi Bahauddin CCI, are accepted as valid and included in the provisional list of voters.

This order is passed on Thursday, 23rd November 2023.
