DECISION # 73 (109 – 278)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Farooq, nominee of Pakistan Electronics Manf Association, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

The learned Council for the Respondent has submitted their two years membership certificate issued by their Association. As far as the issue of corporate entitlement of the respective member is concerned, the NTN return has been submitted which shows that the turnover is well above Rs. 50 Million along with documents showing to be of the same trade.

In the light of above both the nominees seems to be valid. The Complaint is declined.”

Hearing Proceedings:

In the appeal the nominations of the Association has been challenged on the ground that there is no relevancy of business with the TOR of the said Association. The NTN profile does not reflect the company of the nominee on corporate class. Whereas the associate class nominee is not doing business of manufacture of Artificial Leather.

In response, learned Counsel for the Respondents has produced all necessary documents, which shows that the said nominees are fully competent to be nominees of the said Association as they submitted Form 29, Income Tax Returns, and for business relevance also provided Invoices, etc.

Decision of the Election Commission of FPCCI:

In the light of above the appeal is devoid of any merit and is hereby declined and both the nominees of Artificial Leather Manufacturing Association are still valid in Provisional List.

This order is passed on Thursday, 23rd November 2023.
