DECISION # 76 (114 – 285)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellants written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Ms. Mariam Siddiqa and Ms. Gulzaib Waqas Awan, nominees of WCCI Sialkot, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. The nominee from Corporate Class i.e. Ms. Mariam Siddiqa, nominee on GB from Corporate Class, failed to provide 50M Turnover to hold the company shares.
2. Ms. Gulzaib Waqas Awaan, nominee from Associate Class representing from Company i.e. “Speedy Cargo Services” as Partner, where the NTN also shows AOP Status.

In the light of above both the nominees due to serious deficiencies, are not eligible to exist in the provisional list of Voters. The Complaint is accepted.”

Hearing Proceedings:


The learned Counsel for the appellant has raised objection on the decision of SG FPCCI, whereby both the nominees of the said chambers were allowed to be on the Provisional voter list. The learned Counsel for Respondent on Corporate Class has failed to give proof which shows that she is entitled to be nominated on the corporate class whereas the nominee on the Associate class has submitted her Partnership Deed, dated: May 17th, 2005. As such she has proved that she is entitled to be nominee of the said chamber on Associate class. The nominee of corporate class was also asked on phone to verify from her about her corporate status. She however declined to verify the same.


Decision of the Election Commission of FPCCI:

In the light of above the nominee on corporate class is not entitled to be nominee on corporate class whereas the nominee on the Associate Class is entitled to be nominated on Associate class.
This appeal is allowed in aforesaid terms.

This order is passed on Thursday, 23rd November 2023.
