## **DECISION # 78 (117 – 290)**

### **PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)**

Consequent upon Appellants written representation / appeal to the Election Commission of FPCCI, received on 18<sup>th</sup> November 2023 in FPCCI Head Office Karachi from Ms. Humaira Bukhari and Ms. Nasira Yawar, nominees of First Set of Nomination papers, and Ms. Nabeela Farrukh and Ms. Sadia Asif, nominees of Second Set of Nominations from Sahiwal WCCI, on the against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General: Issued on 15<sup>th</sup> November 2023

After going through the said arguments and the documents referred/ submitted, my finding are as follows;

Two sets of nomination has been submitted in respect of subject Chamber.

First sets of Nomination has been submitted which is duly signed by the Secretary General, Mr. Shoaib Dawood, which is duly endorsed by the President, Ms. Humarah Bukhari. The said nomination shows that before nomination an Executive Committee meeting was held on October 24<sup>th</sup>, 2023.

Whereas second set of nominations was also received by this office, which shows that the said nomination has been submitted by President Ms. Nabila Farrukh and counter signed by Secretary General Mr. Rai Amir, which is duly supported by the resolution duly signed by 10 Executive Committee of the said chamber. The council of the said party also stated that an FIR has been lodged against Ms. Humarah and also the said issue is pending before the DGTO office. The next date of hearing in this respect is fixed on 27-11-2023.

In the light of above this dispute the undersigned cannot decide the case at this stage.

Clarification on the decision of the Secretary General of FPCCI, on 16<sup>th</sup> November 2023

“With reference to Decision No. 117 (290) vide letter No. FPCCI.EL2024-25/2023/12146 dated 15<sup>th</sup> November 2023, informed that due a dispute / conflict in the Sahiwal Women Chamber of Commerce & Industry, the undersigned is unable to consider and decide the case. Hence, both the sets of nominations received in FPCCI from Sahiwal Women CCI have not considered as valid.

“In this connection, as per election schedule of FPCCI, the complainant and the respondents may avail the opportunity under Rule 18(6) of TOR 2013 to file an appeal to the Election Commission of FPCCI, by Saturday, 18<sup>th</sup> November 2023 upto 1:30 p.m. at FPCCI Head Office Karachi.”

Hearing Proceedings:

In this matter two sets of nomination were received by the SG FPCCI, which two sets of objections were also submitted by both the groups of the said Woman Chamber, the SG FPCCI has removed both the sets of nominations. Against the said decision this appeal has been instituted.

During the hearing query was made to both the contesting parties to produce the minutes of the Executive Committee meeting which shows that nomination by them has been duly approved.

Both contesting parties agreed to produce the same, but the said documents were only submitted by Ms. Nabila Farrukh, which shows that the Executive Committee has approved the names of Ms. Nabilah Farrukh and Ms. Sadia Asif.

In the light of above, the nominations supported by the Executive Committee of the said Chamber are in accordance with law.


Decision of the Election Commission of FPCCI:


The nominations submitted by Ms. Nabila Farrukh, are accepted, as follows:


1. Ms. Nabila Farrukh, on EC&GB (Corporate Class)
2. Ms. Sadia Asif, on GB (Associate Class)

As such the nomination papers submitted by Ms. Nabila Farrukh are approved to be on the voter list.
