- The Appeal(s) will only be entertained with valid reason(s) and supporting evidences/documents by the appellant(s) on covering letter, with original signature of the Appellant(s) and copy of CNIC of the Member so nominated (who have filed objections earlier to the Secretary General FPCCI) for the year 2024-25.
- Appeals to the Election Commission of FPCCI, received after the due date and time will not be entertained under any circumstances.
- The decisions of the Secretary General FPCCI on the objections filed by the members are already circulated to the objectors / respondents via e-Mail, Courier and posted on FPCCI website www.fpcci.org.pk. Furthermore, the summary of the decisions / actions is also available on FPCCI website.
