

**APPEAL UNDER RULE 18(6) OF THE TRADE ORGANIZATIONS RULES, 2013
AGAINST THE ORDER PASSED BY THE SECRETARY GENERAL OF THE FPCCI.**

Respectfully Sheweth:

- 1). That through the instant appeal the appellant respectfully seek to impugn the Order dated 05-11-2023 ("the **Impugned Order**"). Through the impugned order the Secretary General of the FPCCI, rejected the objection filed by the appellant.
- 2). That the Respondent No.1 filed the objection before the Secretary General of the FPCCI against the Appellant's alleging that for the purposes of enrolling

or renewal of membership of the FPCCI it is condition precedent that the Trade Organization have valid licence under section 3 of the Trade Organizations Act, 2013.

That the licence issued to the Attock Chamber of Commerce and Industry ("ACCI") has been cancelled/expired therefore according to Article 3 of the Memorandum and Articles of Association of the FPCCI read with Article Section 10 of the Trade Organizations Act, 2013 the ACCI is not eligible to be enrolled/admitted as member of the FPCCI, consequently is not eligible to participate in the elections of the FPCCI for the year 2023. It is further submitted that the conduct of the Secretary General and the other staff of the FPCCI be inquired regarding issuance of the renewal of the ACCI with FPCCI in violation of the Trade Organizations Rules, 2013 as well as the Memorandum and Articles of Association.

That the ACCI nominated Mr. Ehtisham Zaman Khan (Corporate) as EC & GB as CEO of M/s Benison Marketing Pvt Limited. The NTN profile reflects that the above said business concern is a body corporate but does not have its annual turnover of Rs. 50 million therefore does not fulfill the criteria of Corporate Member as per Trade Organizations Rules, 2013. The above said is not a valid corporate member of the ACCI consequently could not be nominated as corporate member said nominee is not eligible to participate in the FPCCI's election and his nomination is liable to be rejected.

The appellant further agitated that the ACCI also nominated Mr. Mirza Abdul Rehman as CEO Syntex Pharmaceutical. The said representative fraudulently provided his personal NTN 0913298-8 instead of providing the NTN of the business concern which is 2539378 and has deliberately concealed. The business concern namely Syntex Pharmaceutical does not exist as the said changed its status from Association of person to a Private Limited Company which has also been auctioned in the execution proceedings by the Learned Banking Court, Rawalpindi, therefore, the fake and fabricated business is shown and forwarded to the FPCCI by the so-called Secretary General of ACCI.

The ACCI has failed to hold its annual election for the last four years. The entire conduct of the ACCI's Executive Committee is suspect, as many members of the Executive Committee have expressed their ignorance regarding the conduct of any such election. They have also expressed lack of knowledge regarding any information being given to them with respect to conduct of election of the Executive Committee.

- 3). That the Secretary General of FPCCI through the impugned order failed to appreciate the vital question of law and facts that were urged before the Secretary General Respondent and is liable to be set aside on the following amongst other grounds:-

GROUND S

- a). That the impugned order is against the law, facts and circumstances of the case available on record.
- b). That the Secretary General while passing the impugned order did not apply its judicial mind and rendered the order contrary to the law hence the impugned order is not sustainable in the eyes of law.
- c). That the impugned order was passed without application of mind and reasoning while deciding the objection, thus the same is non speaking order and cannot be sustained in the eyes of law.

That the licence issued to the Attock Chamber of Commerce and Industry ("ACCI") has been cancelled/expired therefore according to Article 3 of the Memorandum and Articles of Association of the FPCCI read with Article Section 10 of the Trade Organizations Act, 2013 the ACCI is not eligible to be enrolled/admitted as member of the FPCCI, consequently is not eligible to participate in the elections of the FPCCI for the year 2023. It is further submitted that the conduct of the Secretary General and the other staff of the FPPCI be inquired regarding issuance of the renewal of the ACCI with FPCCI in violation of the Trade Organizations Rules, 2013 as well as the Memorandum and Articles of Association.

That the ACCI nominated Mr. Ehtisham Zaman Khan (Corporate) as EC & GB as CEO of M/s Benison Marketing Pvt Limited. The NTN profile reflects that the above said business concern is a body corporate but does not have its annual turnover of Rs. 50 million therefore does not fulfill the criteria of Corporate Member as per Trade Organizations Rules, 2013. The above said is not a valid corporate member of the ACCI consequently could not be nominated as corporate member said nominee is not eligible to participate in the FPCCI's election and his nomination is liable to be rejected.

The appellant further submitted that the ACCI has failed to hold its annual election for the last four years. The entire conduct of the ACCI's Executive Committee is suspect, as many members of the Executive Committee have expressed their ignorance regarding the conduct of any such election. They have also expressed lack of knowledge regarding any information being given to them with respect to conduct of election of the Executive Committee, but the Secretary General deliberately has not appreciated the said fact in its order and passed the impugned order unlawfully.

- d). That the impugned order was passed out side of the scope and limitations of the law and is not sustainable.
- e). That the Secretary General FPCCI passed the impugned order in sheer violation of the Trade Organizations Rules, 2013 and the Trade Organization Act, 2013, which provides the complete mechanism for the inclusion/exclusion /deletion of any entry in the Provisional/ Final voter list hence the impugned order is not sustainable in the eyes of law.
- f). That the impugned order was passed in violation of Fundamental Rights and Principles of natural justice. That Rule of Justice demands that before any adverse order, penalty or liability was passed or imposed upon a party, it should be afforded full opportunity to meet the case and rebut the evidence used against it hence the impugned order is not sustainable in the eyes of law.
- g). That the learned Secretary General while passing the impugned order overlooked the factum that the Trade Organization Act,2013 which stipulates the procedure in case of contravention of any provision of the Act or any rule or order or instruction, the impugned order was passed by the learned Election Commission arbitrarily, illegally and tantamount to abuse of law, authority as well as the infringement of constitutional and fundamental rights of the appellant ensured under the constitution of Pakistan, hence the impugned order is void, unfair, unjust, unwarranted, arbitrary, malafide, illegal and ineffective qua the rights of the petitioner.
- h). That the impugned order was passed without application of his independent mind and without even realizing that the impugned order not only illegal but also against the Article 17 of the Constitution of Pakistan, 1973, hence the respondent failed to discharge his duties as per exigencies of his statutory responsibilities and acted in excess of their statutory responsibilities and acted

in violation of his lawful authority and in violation of law and constitutional mandate. Therefore, the conduct of the respondent no.1 & 2 is violative of the dictates of the Honble Superior Court and needs to be judicially reviewed by this Learned Authority.

- i). That the impugned order is based on conjectures and surmises which is not sustainable in the eyes of law.
- j). That while deciding the case and passing the impugned order, the Secretary General did not properly appreciate the documents/evidence on record hence the impugned order is the result of misreading and non-reading of the evidence.

Prayer

In view of the foregoing, it is therefore, most respectfully prayed that while accepting the present appeal the impugned order may kindly be set aside in the interest of justice and the names of the Respondent No. 1 & 2 may kindly be excluded in the Final Voter List of the FPCCI.

Any other relief that this Authority Court deem fit and proper may also be granted to the Appellant Company.
