APPEAL UNDER RULE 18(6) OF THE TRADE ORGANIZATION RULES, 2013 AGAINST ORDER DATED 15.11,2023 PASSED IN COMLAINT UNDER RULE 18(4) OF THE AFORESAID RULES BY SECRETARY GENERAL FEDERATION OF PAKISTAN CHAMBER OF COMMERCE AND INDUSTRIES, KARACHI

Respectfully Sheweth,

That the undersigned has filed the instant representation, being aggrieved of the order dated 15.11.2023 "Impugned Order" passed by the Office of the Secretary General of Federation of Pakistan Chamber of Commerce and Industry "Chair" consequent to the objection petitions filed under Rule 18(4) of the Trade Organization Rules, 2013 and heard on 13.11.2023 and 14.11.2023. The undersigned raised objections against the nominations of Mr. Adnan Javed and Mr. Muhammad Khalil, nominated by Pakistan Cutlery and Stainless Utensils Manufacturers & Exporters Association.

That on the basis of observations the Chair rendered the decision as follow:

"The nominations received from Pakistan Cutlery and Stainless Utensils Manufacturers & Exporters Association are valid and found well in order for needful inclusion in the Provisional List of the Voters issued on 4th November 2023. Moreover, your objections were not substantiated with any prudent evidences and accordingly your objections are declined."

That the undersigned being aggrieved by the Impugned Order has challenged the same on the grounds as follows:

 That the Impugned Order suffers from misreading and nonreading of the facts and record which were also submitted by the counsel for the undersigned during the course of proceedings.

2. That the Chair failed to appreciate the primary grievance of the Appellant that Respondent was not able to demonstrate how he fits into the Corporate Class as the Respondent neither submitted any proof of 50 million turnover for the said business concern. Moreover, the Respondent was not able to demonstrate that they had active business concern engaged in the trade of cutlery which proves that they are eligible to represent the said Association. Moreover, the nominee from associate class was also not able to provide that relevant documents demonstrating that he had active business concern involved in the trade of cutlery.

In the light of aforesaid facts and circumstances it is therefore respectfully prayed that the nominations sent by Pakistan Cutlery and Stainless Utensils Manufacturers & Exporters Association may please be deleted from the Provisional Voter List 2024-2025 as the nominees were not able to provide relevant documents that the Respondent is engaged in the business of cutlery and moreover, fulfills the requisites for their respective classes.
