Dear Members of the Election Commission,

We hereby appeal to the Election Commission of FPCCI against the decision made by the Secretary General of FPCCI regarding our nominations from the Faisalabad Chamber of Small Traders and Small Industry. Our appeal is grounded in the following facts:

- The Secretary General's decision indicates a lack of thorough examination of our case, including the relevant documents and evidence provided in response to the objections raised by our opponents.
- The evidence presented clearly refutes the baseless allegations made by unknown / un-registered complainant M/s. Peshawar Small Traders of Small Industry, by DGTO neither in FPCCI voter list for election 2024-2025 demonstrating that they were unable to substantiate their claims.
- The Secretary General should not have entertained further objections that lack substance and evidence. Unfortunately, he failed to administer justice impartially and, instead, favored to so-called applicant by declaring our nominations invalid without sound evidence.
- The Secretary General has no right to modify the name of applicant or his chamber / association's name which is mentioned in his application at the time of fileing the objections.
- The Secretary General of FPCCI does not possess the authority to remove our names from the list of FPCCI voters, as neither the Trade Organizations Act 2013 (ToA) nor the Trade Organizations Rules 2013 (ToR) empower him to make such decisions.
- Neither the Secretary General nor any member has the right to inquire about the bank account status of any member of the Faisalabad Chamber of Small

Traders & Small Industry. They should refrain from overstepping their domain and avoid acting in a manner similar to FBR or FIA.
