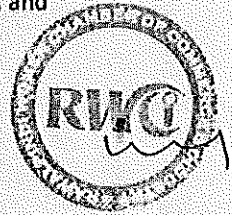

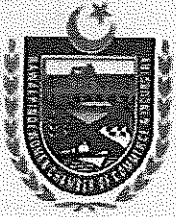

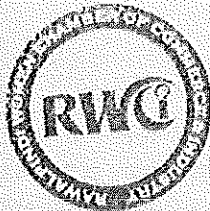

We remain at your disposal for any further clarifications or additional information you may require. Thank you for your attention to this matter, and we anticipate a prompt and favorable response.


