Skardu Chamber of Commerce & Industry has received the Impugned order regarding complaint of Mr. Ehtisham Zaman, CEO M/s Benison Marketing (Pvt.) Ltd, Attack vide letter # FPCCI.EL.2024-25/2023/12145, DATED 15<sup>TH</sup> November, 2023.

- We attended the hearing at zoom on 13TH November, 2023 subsequently on November
   15, 2023 we received order of the secretary general that complainant Mr.Ehtesham
   Zaman has withdrawn his complaint and therefore complaint is dismissed. Copy of said
   email is attached for your kind perusal.
- 2. Later on, after decision of the honorable secretary general, we again received a new order No.FPCCI.EL2024-25/2023/-12190 through email on 17<sup>th</sup> November 2023 that nominations from SKardu Chamber of Commerce are not entitled to include in provisional list of voters issued on 4<sup>th</sup> November 2023. We are surprised how the new order can be issued once the complainant has withdrawn his complaint and without providing proper opportunity of hearing to other party.
- 3. That the Gilgit Baltistan is exempt from income tax, Income Tax Return is not mandatory if the income is exempt, tax is payable on taxable income. Mr. Abid Ali has business both in Pakistan and Gigit also. Reporting of revenue to tax authority in gilgit is not applicable under the law.

- 4. We provided evidence that nominees are from Corproate class and Associate ,it seems the honorable secretary general could not check the attached record.Mr.Arif belongs to Associate Class and 50m Revenue condition does not apply on associate class.
- 5. Both of the nominees are providing services in Gilgit Baltistan, services are not chargeable to sales tax in Gilgit Baltistan. Even there is not sales tax authority in gilgit which can regulate the sales tax on services. Sales Tax registration is required only for the person who conducts taxable activity in the region. Complaint raised by the complainant is based on guess work not based on facts.
- 6. Further, 300 members are required for the renewal of the chamber license. There is no such bar for casting vote in election.

## Prayer:

It is prayed to maintain the first order of the secretary general of the FPCCI against the complaint.
