By this order the undersigned intends to dispose of an appeal filed by Mr. Mehmood Ahmed nominee of Pakistan Commercial Exporters of Towels Association (PCETA) against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding inclusion of nominees of Pakistan Commercial Exporters of Towels Association. The case was fixed for hearing on 30-11-2023 which was attended by both sides.

- 2. Background of the case is that Election Commission, FPCCI vide decision dated 23-11-2023, excluded both the nominees from Pakistan Commercial Exporters of Towels Association by setting aside the decision of the Secretary General, FPCCI, as the license of the Pakistan Commercial Exporters of Towels Association is not registered under Trade Organizations Act, 2013 (ToA 2013), Trade Organizations Rules, 2013 (ToRs 2013), therefore, nominations of the Association could not be entertained.
 - 3. The counsel of the appellant submitted that, the license of the Pakistan Commercial Exporters of Towels Association is not registered under Trade Organizations Act, 2013, Trade Organizations Rules, 2013, therefore, nominations of the Association cannot be considered for nomination of FPCCI elections, 2024-25. Furthermore, both the nominees are not eligible in their respective class of membership to become valid voters.
 - 4. The counsel of the Respondent submitted that although the Association is not registered under Trade Organizations Act, 2013, however, it falls under the category of existing Trade Organization under Trade Organizations Ordinance, 1961 licensed Associationas per Section 4 of the ToA, 2013. Furthermore, the matter is subjudice in Honorable Sindh High Court, Karachi.

FINDINGS:-

Pakistan Commercial Exporters of Towels Association is not registered under Trade Organizations Act, 2013, hence, does not falls under a valid licensed Trade Organization. Furthermore, the appellants failed to provide any documentary evidence to prove their eligibility of memberships. Hence, the instant appeal is liable to be dismissed.
