Date of issuance of Order: 06-12-2023

By this order the undersigned intends to dispose of an appeal filed by Mr. Shakir Ullah nominee of Khyber Chamber of Commerce and Industry (KCCI) against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding

inclusion of nominees of Chitral Chamber of Commerce and Industry (CCCI). The case was fixed

for hearing on 30-11-2023 which was attended by both sides.

2. The background of the case is that the Election Commission FPCCI, vide decision No. 42,

dated 23-11-2023 included the nominees of Chitral CCI in the voter list of FPCCI election 2024-25,

upheld the decision of the Secretary General, FPCCI, and declined the appeal of the appellant.

3. The counsel of the appellant stated that, the subject chamber is totally expired / defunct,

hence, it is not eligible to send nominations to the FPCCI for the elections 2024-25. Furthermore,

both the nominees are not valid members of the Chamber and do not qualify under the respective

classes of membership.

4. The Respondents submitted that both the members are eligible to contest elections.

Furthermore, the Chamber has applied for renewal at the relevant forum.

FINDINGS:-

The license of the chamber is expired since 17-11-2019 and has been declared as time

barred. This TO is totally non-compliant of ToA 2013 and ToRs 2013, specially, Rules 22 and Rule

23 of ToRs 2013.. Hence, the Chamber has lost its representative character as a trade body. The

decision of the Secretary General and Election Commission, FPCCI are, therefore, liable to be set-

aside.

The counsel on behalf of Chitral CCI did not submit any evidence to substantiate

either the validity of the Chamber or compliance of section 6 of ToA 2013 and Rule 22 and 23 of

Tors 2013.

Arguments heard, record perused and relevant provisions of law examined in light of the above the following orders are passed:

- i) The instant appeal is allowed and the decision of Election Commission FPCCI is setaside. The Secretary General, FPCCI is directed to exclude the name of Chitral Chamber of Commerce & Industry (defunct) from final voters list of FPCCI election 2024-25
- ii) The matter stands disposed of accordingly.
