By this order the undersigned intends to dispose of an appeal filed by Mr. Jamal Khan nominee of Hajj Organizers Association of Pakistan against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding exclusion his name from the provisional voters list. The case was fixed for hearing on 30-11-2023 which was attended by both sides.

Background of the case is that, the Secretary General, FPCCI and Elections Commission, FPCCI excluded the name of Mr. Jamal Khan, nominees from Hajj Organizers Association of Pakistan (HOAP) for the FPCCI elections, 2024-2023 on the complaint of Mr. Gul Faraz, nominee of All Pakistan Oil Tankers Owners Association of Pakistan.

During the Course of hearing, the counsel of the applicant has submitted copy of the withdrawal letter from the complainant/ objector, Mr. Gul Faraz Khan.

The withdrawal of objection letter is not opposed by the Respondent, hence, treated as withdrawn.

#### FINDINGS / ORDERS

1. DGTO Office has received a letter No. from the complainant / objector, Mr. Gul Faraz Khan s/o Qebat Shah, CNIC No. 42401-7194037-5, vide his application duly submitted on the letter-head of Pakistan oil Tanker Owners Association withdrew his complaint and appeal.
2. In addition to withdrawal of complaint alongwith the appeal by Mr. Gul Faraz Khan, the nomination of Jamal Khan M/S Wali Hajj Services Pvt Ltd has been found to have fulfilled the requirements of valid nominee for the FPCCI.
3. Accordingly, the Appeal filed by Mr. Jamal Khan before this forum is accepted and the Decision passed by the Election Commission, FPCCI is hereby set-aside.
4. Mr. Jamal Khan nominee of Hajj Organizers Association of Pakistan is hereby included in the final voter list for the FPCCI's election for the year 2024/25.

The matter stands disposed of accordingly.
