By this order the undersigned intends to dispose of an appeal filed by Muhammad Bashir Arain nominee of Khairpur Chamber of Commerce and Industry against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding exclusion of his name from the provisional voters list of FPCCI 2024-25. The case was fixed for hearing on 30-11-2023 which was attended by both sides.

- 2. The background of the case is that the Election Commission FPCCI, vide decision No. 32, dated 23-11-2023, excluded the name of Mr. Muhammad Bashir Arain, nominee from corporate class, of Khairpur Chamber of Commerce & Industry.
- 3. The counsel of the appellant submitted that the Mr. Muhammad Bashir Arain, M/s Adil Traders, nominee from Khairpur Chamber of Commerce of Commerce & Industry was sent to the FPCCI Election, 2024-25 as he fulfills the relevant class of membership and business in the relevant district jurisdiction, however, Secretary General, FPCCI and Election Commission, FPCCI declined the request of the appellant and overlooked the same and excluded the appellant from the provisional voters list.
- 4. The counsel of the Respondent raised the objection on the maintainability of the appeal, as the license of the Chamber is totally expired, in 2018 and 2023 as well, therefore, nominations submitted by the Chamber is invalid. Furthermore, Mr. Muhammad Bashir Arain, failed to prove his eligibility as a valid member in the respective class before the Secretary General and Election Commission, FPCCI.

FINDINGS:-

- i. As per record with this office, the license of Khairpur CCI has expired on 11-04-2018. The Chamber has failed to complete the codal formalities under Section 6 of the ToA 2013 for renewal of its license even after more than 05 years. Hypothetically speaking, even if the license of khairpur CCI is renewed, it will still stand expired on 11-04-2023.
- ii. As of this date, Khairpur CCI is dysfunctional for all practical purposes.
- iii. Communication sent to this chamber regarding rule 22 and 23 of ToRs 2013 were not even responded to ,while the chamber was not expired couple of years back.
- iv. Hence, both the nominees of Khairpur CCI for FPCCI election 2024-25 are liable to be excluded from the voter list.
