By this order the undersigned intends to dispose of an appeal filed by Dr. Shehzad Ahmed nominee of Pakistan Cotton Fashion Apparel Manufacturers and Exporter Association against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding inclusion of nominees of Pashin Chamber of Commerce and Industry. The case was fixed for hearing on 30-11-2023 which was attended by both sides.

2. The background of the case is that the Election Commission FPCCI dismissed the appeal vide decision dated 23-11-2023, of Dr. Shahzad Arshad nominee of Pakistan Cotton Fashion Apparel Manufacturers & Exporters Association on the grounds that he has missed the first forum of objection to the Secretary General of PFCCI.
3. During the hearing on the subject appeal, the counsel of the applicant has not argued his appeal and submitted withdrawal request of his appeal filed under Rule 18(7) of TORs, 2013 before the Regulator (TOs).
4. Respondents did not oppose or pass any comments on the submissions of withdrawal of appeal.

FINDINGS / ORDERS

1. The instant appeal dismissed as withdrawn by the applicant, decision of the Election Commission is upheld.
2. The matter stands disposed of accordingly.
