By this order the undersigned intends to dispose of an appeal filed by Ms. Safia Naz nominee of Charsadda Women Chamber of Commerce and Industry (cancelled) against the nomination of Ms. Zahida Iftikhar nominees of Women Chamber of Commerce and Industry Mardan. The case was fixed for hearing on 01-12-2023 which was attended by both sides.

2. The background of the case is that the Election Commission, FPCCI included the name of Ms. Zahid Iftikhar, nominee from Women Chamber of Commerce & Industry, Mardan in Corporate Class, vide decision No. 24 dated 23-11-2023.

3. The counsel of the appellant has submitted a copy of the withdrawal letter received from the complainant/ objector, Ms. Safia Naz. The withdrawal letter of appeal is not opposed by the Respondents counsel, hence, treated as appeal withdrawn.

FINDINGS/ ORDERS: -

The counsel for the Respondent (Zahida Iftikhar) Mr. Qazi Ahmed Saeed Advocate presented a print of an application attested by the learned counsel himself on behalf of Safia Naz declaring that the complaint was fake and forged. In view of the disowning the complaint by the complainant, the instant appeal is dismissed as withdrawn.

- i. The decision of Election Commission, FPCCI is upheld. The Secretary General FPCCI is directed to include the name of Ms. Zahida Iftikhar nominees of Women Chamber of Commerce and Industry Mardan in the final voter list of FPCCI election 2024-25.
- ii. The matter stands disposed of accordingly.
