By this order the undersigned intends to dispose of an appeal filed by Syed Ali Hammad Kazmi nominee of Live Stock Exporter Association of Pakistan against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding inclusion of nominees of All Pakistan Tyre Importer and Dealer Association. The case was fixed for hearing on 30-11-2023 which was attended by both sides.

2. Background of the case is that Election Commission of FPCCI vide decision No. 12 dated 23-11-2023 dismissed the appeal of Syed Ali Hammmad Kazmi against the decision of the Secretary General, FPCCI for inclusion the nominees of All Pakistan Tyre Importers & Dealers Association in the provisional voters list.

3. During the course of hearing, the counsel of appellant withdrew his appeal.

### FINDINGS/ORDERS

The instant appeal is dismissed as withdrawn by the appellant and the decision of Election Commission, FPCCI is hereby upheld.

The matter stands disposed of accordingly.
