By this order the undersigned intends to dispose of an appeal filed by Mr. Gul Faraz nominee of All Pakistan Oil Tankers Owners Association against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding inclusion of Mr. Shehzad Ali Malik nominee of Rice Exporter Association of Pakistan. The case was fixed for hearing on 01-12-2023 which was attended by both sides.

2. The background of the case is that the Election Commission FPCCI included the name of Mr. Shahzad Ali Malik, nominee form Rice Exporters Association of Pakistan in the provisional voters list vide Decision No. 1 (002-007) dated 23-11-2023.
3. The counsel of the applicant has submitted a copy of the withdrawal letter received from the complainant/ objector, Mr. Gul Faraz Khan.
4. The withdrawal of objection letter is not opposed by the Respondents, hence, treated as appeal withdrawn.

#### FINDINGS / ORDERS

1. DGTO Office has received a letter from the complainant / objector, Mr. Gul Faraz Khan s/o Qebat Shah, CNIC No. 42401-7194037-5, vide his application duly submitted on the letter-head of Pakistan Oil Tanker Owners Association withdrew his complaint and appeal.
2. Accordingly, the Appeal filed by Gul Faraz Khan before this forum is hereby dismissed as withdrawn and decision of the Election Commission is upheld, with the direction to Secretary General FPCCI to include the name of Mr. Shahzad Ali Malik M/S Guard Agricultural Research and Services Pvt Ltd nominee of Rice Exporters Association of Pakistan in the final voter list of FPCCI 2024/25.

The matter stands disposed of accordingly.
