By this order the undersigned intends to dispose of an appeal filed by Mr. Shafqat Ali nominee of Gilgit Chamber of Small Traders and Small Industry against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding inclusion of nominees Quetta Chamber of Small Traders and Small Industry. The case was fixed for hearing on 01-12-2023 which was attended by both sides.

- 2. The background of the case is that the Election Commission FPCCI, vide decision No. 36, dated 23-11-2023, included the nominees Mr. Wali Muhammad and Mr. Naveed Yousaf, nominated by Quetta Chamber of Small Traders and Small Industry, and upheld the decision of the Secretary General, FPCCI, and declined the appeal of the appellant.
- 3. The counsel of the appellant submitted that both the nominees are not eligible to participate in the elections of FPCCI 2024-25, as the license of the Chamber is expired. Furthermore, both the nominees business concerns do not meet the requirement of Small Traders and Small Industry as provided in Rule 3(2)(f) pf ToRs 2013 read with Section 2(s)(t) of the ToA 2013. Furthermore, inclusion of nominees of expired Chamber is in violation of Article 3 of AoA of the FPCCI.
- 4. The counsel of the Respondent submitted that the renewal of license of the Chamber is under process at DGTO Office. The appellants produced documents regarding business concerns in the relevant district and class of membership.

#### FINDINGS:-

The renewal of the license is under process in DGTO Office, both the members fulfills the criteria of valid membership / voters, hence, eligible to participate in elections of FPCCI, 2024-25.

#### **ORDERS:-**

Arguments heard, record perused and relevant provisions of law examined in light of the above the following orders are passed:

- i) The instant appeal is dismissed and the decision of Election Commission FPCCI is upheld. The Secretary General is hereby directed to include the nominees of Quetta Chamber of Small Industry and Small Industry in the voter list of FPCCI election 2024-25.
- ii) The matter stands disposed of accordingly.
