By this order the undersigned intends to dispose of an appeal filed by Mr. Fayyaz Mehmood Sheikh nominee of Shikarpur Chamber of Commerce and Industry against decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI) regarding exclusion of name of Mr. Fayyaz Mehmood Sheikh nominee of Shikarpur Chamber of Commerce and Industry. The case was fixed for hearing on 01-12-2023 which was attended by both sides.

- 2. The background of the case is that the Election Commission FPCCI excluded name of Mr. Fayyaz Mehmood Sheikh, of nominee of Shikarpur Chamber of Commerce and Industry from the provisional voters list, as the nominee failed to appear before the Election Commission, FPCCI. Mr. Pokar Das appeared on behalf of the appellant.
- 3. The counsel of the appellant submitted that he was abroad, when the election commission, FPCCI conducted the hearing and Mr. Pokar Das appeared on behalf of the appellant, however, Election Commission did not entertain the request of Mr. Pokar Das on behalf of the appellant. Furthermore, the appellant submitted all the relevant documents regarding the NTN profile and respective Class of business.
- 4. The counsel of the Respondent, submitted that the appellant failed to avail the remedy under Rule 18(6) of the TORs, 2013, since, Mr. Pokar Das cannot represent another nominee. Also the annual turnover of Mr. Fayyaz Mehmood Sheikh is below the prescribed limit of corporate membership.

#### FINDINGS:-

i. Mr. Fayyaz Mehmood Sheikh is valid member of Shikarpur CCI and fulfills the criteria of Rule 2(1)(g) of the ToRs 2013 to be a corporate member. Hence, the instant appeal is liable to be allowed and his name be included in the voter list of FPCCI election 2024-25.
