## DECISION # KPK-VP-003(A)

### PASSED BY THE ELECTION COMMISSION (FPCCI ELECTIONS 2024-2025)

Under the provision of rule 18(12) of the Trade Organization Rule 2013, the Election Commission of FPCCI entertained the appeal as raised in the application filed by the appellant Mr. Akbar Khan, Candidate for the post of VP KPK FPCCI, for non-inclusion of his name in the provisional list of Candidates for the Election of FPCCI 2024-2025.

The hearing of this case was conducted at the office of Election Commission of FPCCI on 18<sup>th</sup> December 2023.

This appeal has been filed by Mr. Akbar Khan, against exclusion of his name from the Provisional list of Candidates for the post of Vice President from KPK Chambers on the ground that his name is not mentioned in the provisional list of candidates.


The appellant has submitted five nomination forms and the Election Commission of FPCCI has received the nomination as per following in the provisional list of candidates.

- Form-1 is rejected due to proposer is not from the Electoral College of the Candidate as per Rule 18(9) of TOR 2013, read with Rule 20(6) (a) to (e).
- Form-2 is hereby accepted, because of inclusion of proposer name in the final voters list vide Addendum No. 3 dated 13<sup>th</sup> December 2023.
- Form-3 is rejected due to proposer and seconder are not from the Electoral College of candidate as per Rule 18(9) of TOR 2013.

#### Decision of the Election Commission:

Reference Addendum No. 3 issued by the Election Commission of FPCCI, the Election Commission is pleased to accept the Form-2 as described at 'b' above. Therefore, the nomination of Mr. Akbar Khan, Candidate from VP KPK Chambers is hereby accepted in the provisional list of candidates.
