## DECISION # SMALL-VP-005

### PASSED BY THE ELECTION COMMISSION (FPCCI ELECTIONS 2024-2025)

Under the provision of rule 18(12) of the Trade Organization Rule 2013, the Election Commission of FPCCI entertained the appeal as raised in the application as filed by the Appellant namely Mr. Tariq Mehmood Jadoon, for non-inclusion of his name in the provisional list of Candidates for the Election of FPCCI 2024-2025.

The hearing of this case was conducted at the office of Election Commission of FPCCI on 18<sup>th</sup> December 2023.


Mr. Tariq Jadoon has submitted his appeal that his name has been removed from the Provisional list of Candidates from Small Traders & Small Industry, on the ground that his Proposer has also proposed Muhammad Saqib Abbasi, who is also contesting on the same position.


During the hearing the said Proposer, Mr. Taj Muhammad, submitted his personal affidavit in support of Mr. Tariq Mehmood Jadoon, wherein he stated that he has not proposed or seconded any other candidate for the seat of Vice President of FPCCI. On the other hand, the other candidate proposed by Mr. Tariq Mehmood Jadoon, namely Mr. Muhammad Saqib Abbasi also submitted affidavits of Mr. Abdul Qasim S/o. Abdul Hakeem of Mardan Chamber of Small Traders & Small Industry Mr. Waqar Ahmad Nayar S/o. Muhammad Sharif of Jhang Chamber of Small Traders and Industries, Mr. Ghulam Nasir S/o. Ghulam Qadir of Hunza Chamber of Small Traders and Small Industries, Ch. Saeed S/o. Ch. Nazeer of Islamabad Chamber of Small Traders and Small Industries, etc. He also admitted that the said proposer has signed in front of us in favour of M. Tariq Jadoon.


#### Decision of the Election Commission:

A proposer can only propose one candidate for the post of VP from Chamber of Small Traders and Small Industry. In this case Mr. Tariq Mehmood Jadoon appears as proposer on three different nominations. His affidavit regarding proposing only Mr. Tariq Mehmood Jadoon stands falsified by his signatures on two other nomination forms. His plea that he signed blank documents is not acceptable, in view of affidavits submitted by the other candidate.

Therefore, the appeal is hereby declined.
