Ltd., which is available at Serial No. 298 of the Final voter list issued by the FPCCI. The NTN of the appearing as 1137731-3. Enclosed please fine the attached letter issued by DGTO in which the Competent Authority has Executive Committee of said Trade Body. The Nomination of Mr. Muhammad Tauqeer Malik has not approved by Executive Committee. Air Cargo Agents Association of Pakistan is a defunct Association and is not following rules of Trade Organisation and failed to compliance of DGTO Orders.
  - 11. That in light of the judgment passed by the Honourable Islamabad High Court in Writ Petition No. 4172/2019, titled as Aftab Ahmed Barlas vs Director General Trade Organizations and Others (2021 CLD 204), if a member is not qualified to be member of the trade body, then it would also not be eligible to represent that trade body in the FPCCI elections. It is further submitted that the Honourable Islamabad High Court in Writ Petition No. 4682/2018, titled as Noor Ahmed Khan and another vs Director General Trade Organizations and Others disqualified the office bearer (Vice President of Association for FPCCI) of the FPCCI on account that the said individual was not a valid member of its own trade body i.e. All Pakistan Fruit and Vegetable Exporters, Importers and Merchant Association.




By this order the undersigned intends to dispose of an appeal filed by Mr. Tariq Mahmood, coordinator of Interim Committee, Air Cargo Agents Association of Pakistan (ACAAP) against Mr. Mohsin Abbas Dharsi, Ex-Chairman, ACAAP, member of Interim Committee, ACAAP and Mr. Rehan Ali Ratnani, Ex-Executive Committee members, ACAAP. The case was fixed for hearing on 21-09-2023, which was attended by relevant parties.

- 2. Background of the case is that Regulator (TOs) vide Order No. 13/2023 dated 08-06-2023 constituted an interim committee of Air Cargo Agents Association of Pakistan (ACAAP) in compliance with the order of Committee of the Federal Cabinet dated 31-03-2023, to run the affairs of the Association and for compliance of directions in the order.
- 3. That the applicant was nominated as a coordinator of the Interim Committee, ACAAP. During the course of hearing, the applicant pointed out severe irregularities committed in the affairs of the Association by the previous management of the Association. These irregularities broadly include financial misappropriation/embezzlement as well as contravention of Rule 21(15) of Trade Organization Rules, 2013.
- 4. That Mr. Mohsin Abbas Dharsi remained Chairman of the Association in following years 2016-17, 2017-18, 2018-19, 2019-20, 2021-22, 2022-23 without any legal position / orders, which is a clear violation of Rule 21(15) of Trade Organizations Rules, 2013. During his tenure as Chairman, he manipulated / committed many financial misappropriations / embezzlements in the funds of the Association, one of them being the personal grants and subsidies granted to his relatives especially his son and nephew. Mr. Mohsin Abbas Dharsi also illegally used ACAAP funds in unnecessary foreign tours. Mr. Hassan real son of Mr. Mohsin Abbas Dharsi, conducted different courses from his academy (Aviation + DG Training School) by using the name of the TO, conflicting interest and also offense under the TOA, 2013 and TORs, 2013.
- 5. Mr. Mohsin Abbas Dharsi illegally used funds of the Association amounting to Rs. 70.00 lakh (Seven Million Rupees) to put association in unnecessary litigation. During his tenure, the Association also violated the Order No. 5/2020 dated 27-01-2020 by conducting elections of the Association in 2020-21 without any constituted committee of the DGTO Office.



- 6. That, Mr. Rehan Ali Ratnani, Ex-member of Executive Committee, ACAAP with the company name KCS Xpress Pvt Ltd used his personal residence for regional office of ACAAP @ 26,000/- per month rent without any legal position and violation of Rule 6(i) of TORs, 2013, whereas the amount of the total rent amounting to Rs. 1,347,650/- is paid to KCS Xpress Pvt Ltd, the amount was, however, returned by Mr. Rehan Ali Ratnani on the observations of the Interim Committee of ACAAP. During the scrutiny of record. Mr. Rehan Ratnani is the nephew of Mr. Mohsin Abbas Dharsi. Mr. Rehan Ali Ratnani remained part of the team of Mr. Mohsin Abbas Dharsi in financial misappropriations with the funds of the Association.
- 7. The applicant coordinator of the Interim Committee, ACAAP has requested the DGTO Office to cancel the memberships of Mr. Mohsin Abbas Dharsi and Mr. Rehan Ali Ratnani from the Association and Mr. Mohsin Abbasi Dharsi name may also be removed from the member list of Interim Committee. The applicant has also requested that 3<sup>rd</sup> party audit of accounts of the Association for past 05 years may be conducted from a well reputed charted accountant firm.
- 8. Mr. Mohsin Abbas Dharsi and counsel appeared in the hearing on behalf of respondents. The counsel denied the allegations of the applicant and stated that the applicant remained in litigation since long and DGTO Office has issued many orders in this regard. However, Mr.Mohsin Abbas Dharsi admitted the irregularity pointed out by the Coordinator of the Interim Committee regarding his tenure as a Chairman in the Association. Mr.Mohsin Abbas Dharsi admitted that Academy of his son namely (Aviation +DG Training School) was used for the professional training of the members of the ACAAP.
- 9. The counsel on behalf of Mr. Rehan Ratnani submitted that KCS provided the services as regional office of the ACAAP, Lahore and TO was paying rent amounting to Rs. 26,000/-. However, on the demand of Interim Committee the respondent returned the whole amount collected as rent from the Association and back to the Association.

10. The counsel submitted that most of the DGTO Office orders were challenged at various appellate foras, therefore, a huge amount is spent from the account of the Association.

#### **FINDINGS**

Rule 21(15) of Trade Organizations Rules, 2013 states that:-

"On completion of term, office-bearers and members of the executive committee shall not be eligible to contest election or co-option in any representative capacity in the trade organization for the next one year".

From the arguments heard in the hearing and perusal of the record, it is apparent that the procedure for appointment of office bearers especially Chairman of the Association as laid down in Rule 21 of TORs, 2013 has not been followed. Moreover, no evidence has been submitted by the respondent to justify to the Regulator, that contravention of Rule 21(15) of TORS, 2013 has not been committed. Furthermore, documents submitted to the Regulator show that proper procedure in appointment of the office bearers has not been followed in manner prescribed in the Trade Organizations Act, 2013 and Rules made thereunder. As such, it is clear there are legal infirmities in the management and organizational structure of the ACAAP, and that the Association did not adhere to the Trade Organization Act, 2013 and Rules made thereunder.

- 2. It is clear from the record provided by the coordinator of the Interim Committee of the ACAAP that Mr. Mohsin Abbas Dharsi remained Chairman of the Association consecutively in the year 2016-17, 2017-18, 2018-19, 2019-20, 2021-22, however, no elections of the TO were conducted in the 2022-23 due to subjudice status of the ACAAP. However, Mr. Mohsin Abbas Dharsi kept using the name and style of the Chairman of the Association in the year 2022-23. Mr. Mohsin Abbas Dharsi was also found exercising unauthorized use of his powers being the Chairman of the Association with regards to misappropriations / financial embezzlements. He is liable to be penalized under Section 25 of Trade Organizations Act, 2013. Mr. Mohsin Abbas Dharsi has been found to have contravened provisions of TOA 2013, and TORs, 2013, hence, his membership may be restricted under Section 20(2) of Trade Organizations Act, 2013 for next five years.
- 3. Mr. Rehan Retnani, KCS Xpress Pvt Ltd, Ex-member of the Executive Committee, ACAAP, has also been found to have contravened provisions of TOA 2013 and TOR 2013, by providing his personal residence to the Association as regional office and was found involved in financial mismanagement. Hence, his membership is also liable to be terminated.

- 4. It is also abundantly proven that Mr. Mohsin Abbas Dharsi has violated Rules 21(15), 23(2) and 27 of Trade Organizations Rules, 2013 by not providing any evidence to disprove the claim of the applicant.
- During the tenure of the previous management of the ACAAP, the Association failed to run its affairs in accordance with the Trade Organizations Act, 2013 and Trade Organizations Rules, 2013. In light of irregularities pointed out by the Interim Committee of the ACAAP and as per available record, an impartial audit from the well reputed chartered firm for last 05 years may be ordered.

#### **ORDER**

Arguments heard and record/ evidence perused, the following orders are passed:-

- The Membership of Mr. Mohsin Abbas Dharsi and Mr. Rehan Ali Retnani of ACAAP is hereby terminated under Rule 11(3) of TORs, 2013 with immediate effect.
- ii. Under Section 20(2) of the TOA, 2013, Mr. Mohsin Abbas Dharsi has been found convicted of various offences under this Act, therefore, he shall not hold, or be eligible for holding, any office in a registered trade organisation for next 05 years.
- iii. Mr. Mohsin Abbas Dharsi's name is removed from the Interim Committee; the Interim Committee is directed to nominate a new member to the Interim Committee in his place.
- iv. Fresh financial audit of the ACAAP by a well reputed Chartered Accountant firm shall be conducted by the Interim Committee for the last 05 years and a report is to be submitted to this office within 60 days accordingly.
- v. The Coordinator Interim Committee and Secretary General, ACAAP will reconcile the compliance report with DGTO Office within 30 days of receipt of this order.

The matter stands disposed of accordingly.
