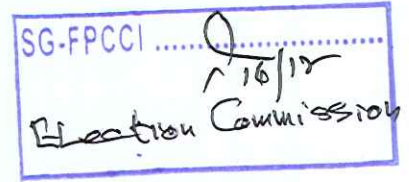

Respectfully Sheweth,

1. That the instant objections are being filed under Rule 18(12) of the Trade Organization Rules, 2013 whereby the undersigned have raised considerable objections on the nomination of Mr. Asif Sakhi, nominee for the election of Vice President for the year 2024-2025. The nomination of Mr. Asif Sakhi is contrary to the criterion provided by the Trade Organization Rules, 2013 as well as Trade Organization Act, 2013.

2. That the nomination of the aforesaid nominee is against the eligibility criteria as set in the Trade Organization Rules as well as Trade Organization, Act 2013 on the grounds inter alia as follow:


A. That Mr. Asif Sakhi is representing the business concern namely Sakhi International which was issued license of the Pakistan Customs Clearance Association in the year 2022, the same can be confirmed by the fact that the aforesaid nominee was not a member of All Pakistan Customs Clearance Association in the 2021 and no proof was given in same regard. Hence, Mr. Asif Sakhi has not completed tenure of 2 years for the voting eligibility in accordance with Rule 15(1)(a) of the Trade Organization Rules, 2013. Moreover, All Pakistan Customs Clearance Association is a defunct as the license of All Pakistan Customs Clearance Association was not renewed within cut off time.

B. That the judgments pronounced by the Hon'ble Court, more particularly reported as **PLD 2021 ISB 204, 2020 CLD 121 and Gulzar Feroz VS DGTO**; have held that the requirements qua eligibility of membership, eligibility to vote and other conditions required by the Trade Organizations Act, 2013 and the Trade Organizations Rules, 2013 are to be mandatorily and compulsorily met, even a nomination of a purported member which is in negation of, violation of or contrary to the provisions of the Trade Organizations Act and Rules, such nominations are to be rejected forthwith.

**PRAYER:**

In light of the facts and circumstances as mentioned above it is therefore respectfully prayed from the Hon'ble Election Commission of the FPCCI that the nomination of Mr. Asif Sakhi may please be set aside as the same stands in contrary to the Trade Organization Act and Rules 2013 as the nominations have been sent by a defunct Trade Body as well as the member is not eligible to vote.

  - A. That Mr. Muhammad Ali Haider is coming from associate class whereas the business concern nominating him is a private limited entity.
  - B. That the judgments pronounced by the Hon'ble Court, more particularly reported as **PLD 2021 ISB 204, 2020 CLD 121 and Gulzar Feroz VS DGTO**; have held that the requirements qua eligibility of membership, eligibility to vote and other conditions required by the Trade Organizations Act, 2013 and the Trade Organizations Rules, 2013 are to be mandatorily and compulsorily met, even a nomination of a purported member which is in negation of, violation of or contrary to the provisions of the Trade Organizations Act and Rules, such nominations are to be rejected forthwith.

**PRAYER:**
