OBJECTIONS UNDER RULE 18(12) OF THE TRADE ORGANIZATION RULES, 2013

Respectfully Sheweth,

- 1. That the instant objections are being filed under Rule 18(12) of the Trade Organization Rules, 2013 whereby the undersigned have raised considerable objections on the nomination of Mr. Mirza Ishtiaq Baig nominee for the election of Senior Vice President for the year 2024-2025. The nomination of Mr. Mirza Ishtiaq Baig in contrary to the criterion provided by the Trade Organization Rules, 2013 as well as Trade Organization Act, 2013.
- 2. That the nomination of the aforesaid nominee is against the eligibility criteria as set in the Trade Organization Rules as well as Trade Organization, Act 2013 on the grounds inter alia as follow:
- A. That the nominations of Mr. Mirza Ishtiaq Baig has been submitted fraudulently, as the aforesaid nominee do not have any active business concern related to the manufacturing and export of denim. The undersigned has presented Form 29 issued by the SECP showing him as Director in Pakistan Denim Limited but however, no substantial evidence was provided by the undersigned as how the entity engaged in the manufacturing and export of Denim. Neither any export GD nor any Sales Tax Invoice was provided regarding the manufacturing, export or any other relation to Denim. Moreover, the FBR Online Inquiry also provided that main source of Income was that of rental income.
- B. That the judgments pronounced by the Hon'ble Court, more particularly reported as PLD 2021 ISB 204, 2020 CLD 121 and Gulzar Feroz VS DGTO; have held that the requirements qua eligibility of membership, eligibility to vote and other conditions required by the Trade Organizations Act, 2013 and the Trade Organizations Rules, 2013 are to be mandatorily and compulsorily met, even a nomination of a purported member which is in negation of, violation of or contrary to the provisions of the Trade Organizations Act and Rules, such nominations are to be rejected forthwith.

Prayer:

In the light of aforementioned facts and circumstances it is therefore prayed from this Hon'ble Election Commission that the nominations of Mr. Mirza Ishtiaq Baig may please be set aside and rejected.
