3. One applicant can be a member of more than one Business Council subject to payment of prescribed fee for that Council, and can also contest election to the Board of Directors of more than one Business Council.
4. Those members who wish to cast their vote through proxy will submit their proxy on company's letter head on or before the date stipulated in **Column No.7** to FPCCI Head Office Karachi.
5. Those members who desire to withdraw their nomination will submit their withdrawal on company's letter head on or before the date stipulated in **Column No. 7** to FPCCI Head Office Karachi.
6. Nine (9) members are to be elected to the Board of Directors of each Business Council.
7. The Chairman of the Business Councils will be nominated by the President FPCCI from amongst the elected Board of Directors of the concerned Business Council.
8. Elections to the Board of Directors of a Business Council will be held only if; there are at least 20 valid members in that Business Council as that is the minimum requirement for holding of election/activation to the Council. Otherwise the election to the concerned Business Council will be postponed.
9. One company has one voting right only.
10. Only those Companies whose businesses are registered in Pakistan can become members of the Business Councils of FPCCI.


